Background:

The NHS Data Model and Dictionary Service receive help desk queries regarding the format and length of organisation codes and default codes held in the NHS Data Model and Dictionary and use of the Commissioning Data Set Addressing Grid.

This Data Dictionary Change Notice updates the NHS Data Model and Dictionary as follows:

- updates the Data Elements to clarify information as raised through help desk calls;
- updates the Data Element "Organisation Code (Code of Commissioner)" to reference the Department of Health document "Who pays? Establishing the Responsible Commissioner", which sets out a framework for establishing responsibility for commissioning a patient's care within the NHS;
- changes the layout of the Commissioning Data Set Addressing Grid to make it easier to use;
- renames the existing "Default Codes Summary Table" to "Organisation Data Service Default Codes";
- Data Elements:
 - Replaces the links to the Organisation Code or Organisation Site Code Attribute with the correct Format/Length for the Data Element
 - Where "Organisation Data Service Default Codes" are appropriate, renames "Default Codes" to "ODS Default Codes"
 - Removes the existing link to the Default Codes Summary Table and provides the appropriate "ODS Default Code(s)"
- updates the NHS Postcode Directory page;
- adds new NHS Business Definitions for:
 - Care Trust;
 - Community Health Partnerships (Scotland);
 - Local Commissioning Group (Northern Ireland);
 - National Commissioning Group;
 - National Specialised Commissioning Group;
 - Primary Healthcare Directorate (Isle of Man);
 - Scottish Health Board
- renames Local Health Board to Local Health Board (Wales) to make it clear that this is referring to a Welsh organisation.

This Data Dictionary Change Notice does not contain a change to the information held in the NHS Data Model and Dictionary Service. It is a change of layout and clarification of information only, to make the information clearer for users. All changes have been agreed with the organisation responsible for the information.
