Background:

The Healthcare Commission, Commission for Social Care Inspection and the Mental Health Act Commission ceased to exist on 31 March 2009.

Data Set Change Notice 12/2009 (Data Standards: Care Quality Commission) changed all references in the NHS Data Model and Dictionary from the Healthcare Commission to the Care Quality Commission and added a summary of the responsibilities of the new organisation.

This Data Dictionary Change Notice:

- removes all references to the Commission for Social Care Inspection and the Mental Health Act Commission
- updates the description and items related to Children's Homes as they are now registered with Ofsted, not the Care Quality Commission

It also:

- Adds missing links to existing NHS Data Model and Dictionary items
- Removes unnecessary abbreviations and references.

Note: The Department for Children, Schools and Families has been replaced by the Department for Education. A separate Data Dictionary Change Notice will be published to make the appropriate changes.
