#### Background:

The 2012 Health Act made changes to the structure of the NHS.

A number of requirements for the Organisation Data Service standard have already been defined within [ISN ISB 0090 Amd 5/2012 - Health and Social Care Bill Changes](#) and [ISN ISB 0090 Amd 37/2012 - ODS Non-Legislative Organisations](#), which included the addition of NHS Business Definitions for new organisations which will come into existence on 1 April 2013.
