Background:

Following an enquiry to the NHS Data Model and Dictionary helpdesk it was identified that Religious or Other Belief System Affiliation was incorrectly modelled.

This Data Dictionary Change Notice (DDCN) retires the Class "Religious or Other Belief System Affiliation Group Code" and adds the Attribute "Religious or Other Belief System Affiliation Group Code" to the Class "Religious or Other Belief System Affiliation".

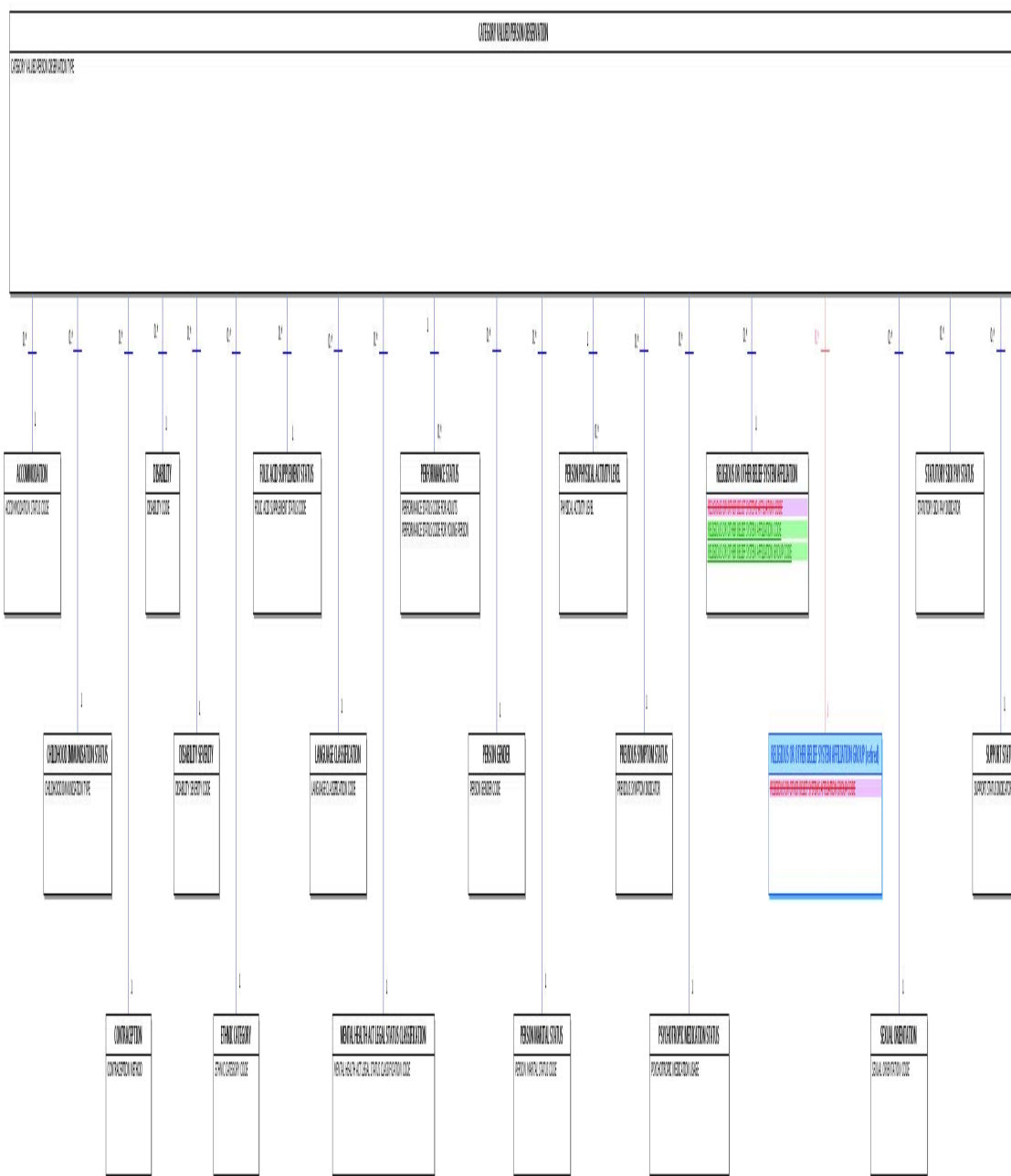
