#### Background:

The Information Standards Board for Health and Social Care (ISB) has conducted a review of all Data Set Change Notices (DSCNs) and Information Standards Notices (ISNs) issued since 1987, to update its portfolio of standards prior to the handover of responsibility to NHS England, the Health and Social Care Information Centre (HSCIC) and Public Health England.

This review has identified a number of data standards in the NHS Data Model and Dictionary which have been superseded or are no longer in use.

This Data Dictionary Change Notice (DDCN) retires the items in the NHS Data Model and Dictionary in line with the retirement of the following Data Set Change Notices, as listed on the ISB [Advanced Notification - Withdrawal](#) issued 26/09/13:

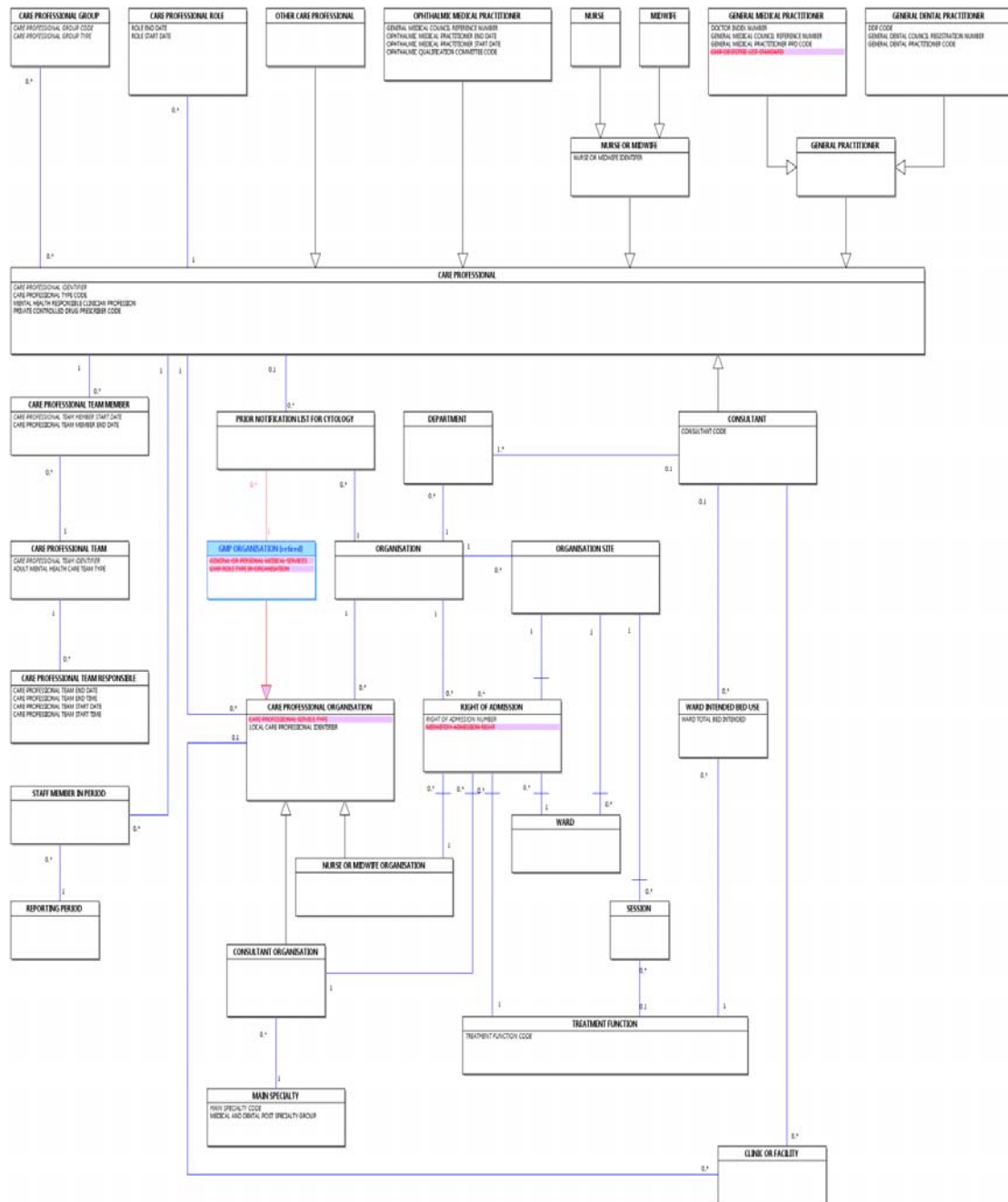

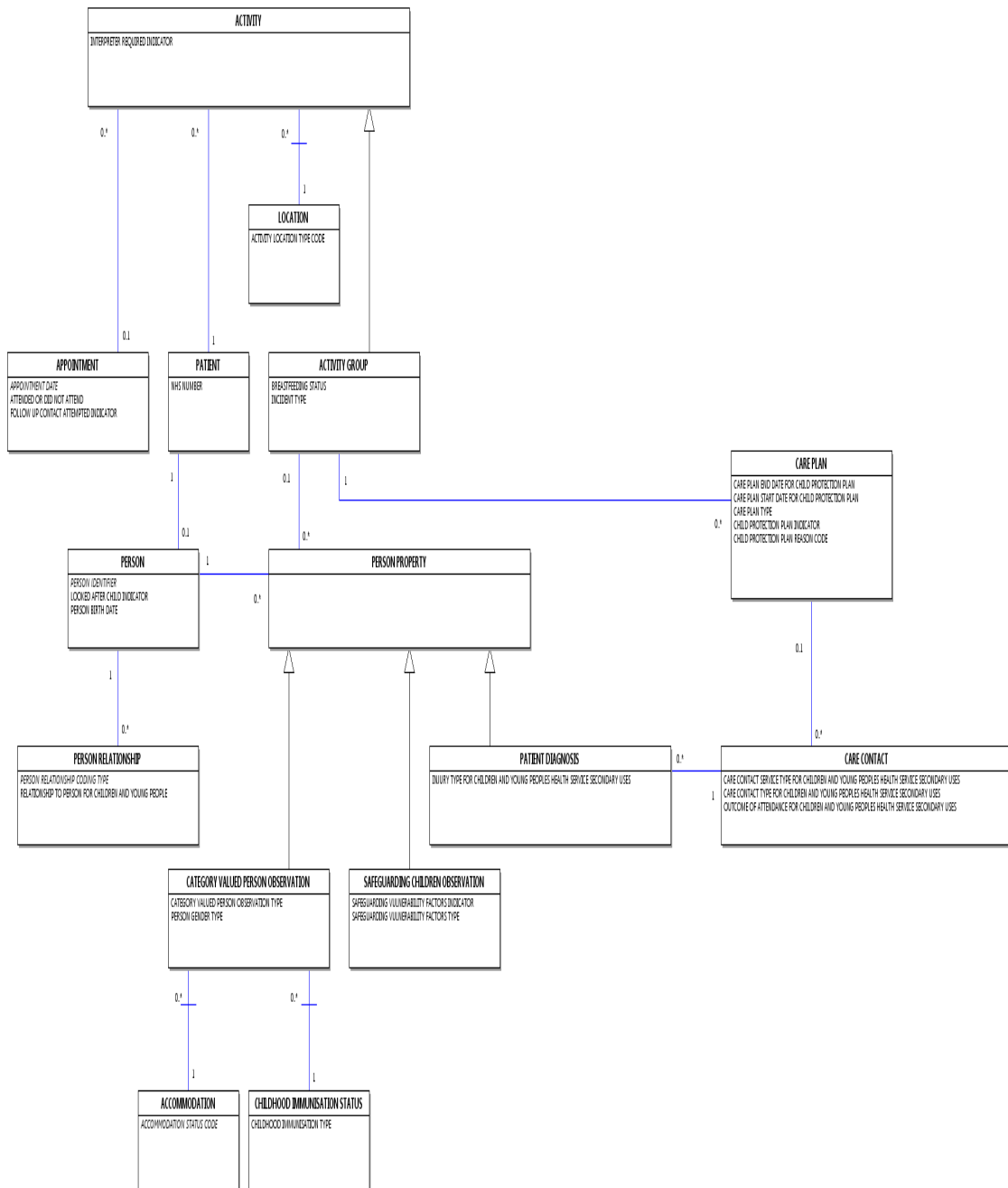






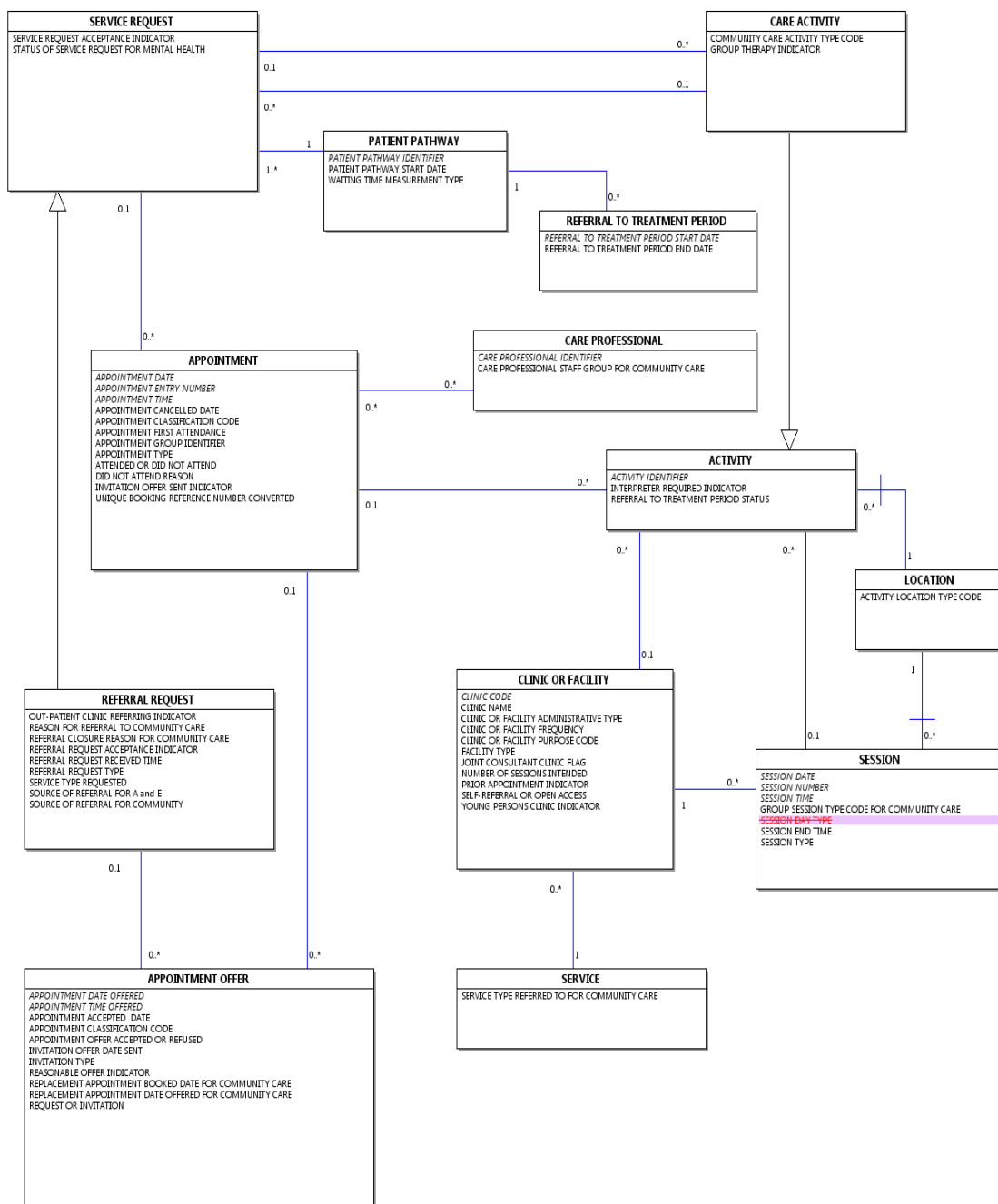
# CHILDREN AND YOUNG PEOPLE'S HEALTH SERVICE SECONDARY USES DIAGRAM
