Background:

[DDCN 1189 - National Institute for Health and Clinical Excellence](#) introduced a definition for the National Institute for Health and Clinical Excellence.

In April 2013 the National Institute for Health and Clinical Excellence became a Non Departmental Public Body (NDPB) and took on responsibility for developing guidance and quality standards in social care. The name was changed to the National Institute for Health and Care Excellence (NICE) to reflect these new responsibilities.

This Data Dictionary Change Notice (DDCN) updates the NHS Data Model and Dictionary to reflect this change.

An [Antenatal Booking Appointment](#) is a [CARE CONTACT](#).

An [Antenatal Booking Appointment](#) is the [APPOINTMENT](#) where the woman enters the maternity care pathway, characterised by information giving and detailed history-taking to help the woman choose the most appropriate [Antenatal](#) care pathway.

It also includes measurement of [Height](#), [Weight](#), [Blood Pressure](#) and blood tests for determining blood group, rubella status and haemoglobin level. Blood and urine samples for screening may also be taken at [Antenatal Booking Appointment](#) after the woman has been well informed and has given her consent. The [Antenatal Booking Appointment](#) follows the first contact with a health professional.
