Background:

The contract covering UNIFY2 is due to expire at the end of March 2018.

The technical solution is in place for the transition of data collections from Unify2 to the Strategic Data Collection Service (SDCS).

This Data Dictionary Change Notice (DDCN):

- Adds the NHS Business Definitions for:
 - Strategic Data Collection Service (SDCS) and
 - Data Services Platform (DSP)
- Updates the Unify2 NHS Business Definition to indicate it will no longer be in use from April 2018
- Links the existing reference to the "Strategic Data Collection Service" on the Stop Smoking Services Quarterly Data Set Overview.

Note: Data Sets that reference Unify2 will be updated when they are progressed through the Data Coordination Board (DCB).

Collection and Submission

The [Stop Smoking Services Quarterly Data Set](#) is required by [Public Health England](#) and is collected from [Local Authorities](#).

The [Stop Smoking Services Quarterly Data Set](#) relates to [ACTIVITY](#) taking place over a 3 month period and should be submitted by the thirty second working day after the end of the quarter to which it relates.

The [Stop Smoking Services Quarterly Data Set](#) is transmitted at aggregate level to the [NHS Digital Strategic Data Collection Service](#) available at [NHS Stop Smoking Services](#).
