Background:

Contact has been made with the Care Quality Commission (CQC), who regulate Care Homes, who have confirmed the correct terms are "Care home services with nursing (CHN)" and "Care home services without nursing (CHS)", see: [Service types: Residential social care](#).

This Data Dictionary Change Notice updates the NHS Data Model and Dictionary to:

- Rename the NHS Business Definitions "Care Home With Nursing" and "Care Home Without Nursing" and update the descriptions to match the Care Quality Commission website
- Update all items that reference "Care Home With Nursing" and "Care Home Without Nursing" to reflect the changes.

People may live in a [Care Home](#) for short or long periods. For many people, it is their sole place of residence and so it becomes their home, although they do not legally own or rent it. Both the care that people receive and the premises are regulated by the [Care Quality Commission](#). PEOPLE may live in a [Care Home](#) for short or long periods. For many PEOPLE, it is their sole place of residence and so it becomes their home, although they do not legally own or rent it. Both the care that PEOPLE receive and the premises are regulated by the [Care Quality Commission](#) (CQC).

The [Care Quality Commission](#) definition of personal care [SERVICES](#) is:

The provision of personal care for PEOPLE who are unable to provide it for themselves because of old age, illness or [DISABILITY](#). The personal care must be provided in the place where those PEOPLE who need it are living at the time when the care is provided.
